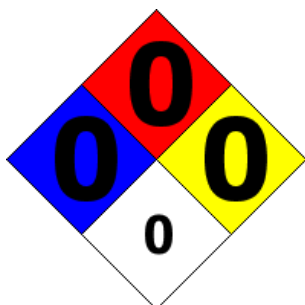

### SECTION 4 : First aid measures

#### Description of first aid measures
